- 1. Call to order and declare quorum

  - The Steering Committee members made several suggestions and approved the changes and suggested implementation plan proposed by Bruce and with an implementation trial beginning with the June 12<sup>th</sup> ride.

    information in the ride schedule and Bruce will input this information into the Event/Calendar
    section on the CCCTS website.
  - It was agreed that the map library needs to be updated.

Chris reported on the results of the vote with the jersey design proposed by the Ottawa Chapter

being the clear winner. The next step (already underway) is to finalize the ordering and payment arrangements with the manufacturer and then inform prospective purchasers.
