Rides Subcommittee

Advocacy Subcommittee

Neil reported that the BC Motor Vehicle Act has been amended to require drivers to use appropriate care when sharing the road with pedestrians and cyclists. Drivers must be a minimum of one meter away when passing and stay 3 meters behind cyclists when sharing the lane.

In response to Ralph's question, Neil will follow up with Surrey on the issue of installing road sign on the one meter passing rule.

Communications Subcommittee
