Fraser Valley Chapter, CCCTS – Advocacy Committee

One of the key purposes of CCCTS is to encourage and support bicycling for transportation, recreation and sport. One of the ways the FV chapter works towards meeting this objective is through our Advocacy Committee. We are part of a coalition consisting of 2 Local Committees of HUB (the Surrey-White Rock and the City/Township of Langley (TOL) Committees), 0-5-0 members and CCCTS members. Through liaison and cooperation with our local government bodies, we have established a strong voice that is being heard on all local transportation issues that have an impact on bicycling. HUB takes the lead and presents our comments and feedback on pending project work and current cycling concerns. We have found it more effective to be a single voice when approaching government.

The following is a condensed list of projects that the coalition had involvement with:

- 152nd Street Upgrade (2023)
- King George Blvd Repaving (buffered) (2022)
- Surrey City Centre Quick-Build Lanes (2022)
- Multi-Use Pathways (MUPs) on 32nd Ave from 152 Street to 164 Street (2022)
- The new painted bike lanes along 74 Avenue from King George Blvd to 138 Street (2021)
- Provided a letter of support to BC Cycling Coalition's petition to the Provincial government in support of the proposed changes to the Motor Vehicle Act that would require motorist to give cyclists a minimum of 1 meter passing space and 3 meters following space. These changes have now been tabled in the Legislature and will likely come into effect in the New Year.
- Hub Langley has worked towards promoting cycling as an alternative to short transportation trips that did not necessitate the use of a large vehicle. In that vein, the Committee approached local government and the business community about the need for secure end-of-trip bike parking. This is one area where we were able to see immediate action taken. Fort Langley being the best example, where the Township agreed to install 9-hoop bike racks in various locations throughout the village.
- The Local Committee provided input to the Ministry of Transportation & Infrastructure with regards to the design of the new Glover Road overpass over Highway #1 to ensure that cyclist needs were addressed.
- Provided feedback to TransLink and local government regarding the effectiveness of the separated bike lanes on 96th Avenue and the Telegraph Trail in Walnut Grove.
- Lobbied local government transportation staff to address the hazardous conditions of the designated bike route through the Murray Creek Ravine on 40th Avenue.
- Addressed the need for closing the GAP on various bike routes between Surrey and Langley. As an example, the gap between 200th and 192nd Streets at 36th Avenue.
- HUB Langley addressed the need for safer cycling infrastructure on 216th Street. TOL tweaked their plans in response to
 feedback and has completed the section of 216th Street between Telegraph Trail and 88 Avenue. There are now wide MUPs
 for cyclists on both sides of the street. The committee continues to lobby the TOL for protected bike lanes on 216th Street
 from 88 Avenue to 96 Avenue.
- A lengthy reconstruction of the 200th Street freeway overpass has included an important safety improvement for
 pedestrians and cyclists. The Ministry of Transportation & Infrastructure has installed crosswalks and crossing lights on the
 southwest slip lane to make it safer for people to cross at this freeway exit. The Committee has been lobbying the Ministry
 of Transportation & Infrastructure to do the same on Glover Road at Highway 10.
- Provided input to a consultant's work regarding a project in the Village of Fort Langley regarding bike infrastructure.
- Ongoing service requests have been submitted to City Operations and Bylaw Departments to address hazardous road
 conditions: potholes, lack of or inadequate signage protecting cyclists on designated bike routes, poor sight lines, motor
 vehicle encroachment/parking on designated bike routes/lanes.
